The wholesale murder of innocent people by a jihadi in Florida makes the very point Gran’pa Jack explains: Evil exists in the world and no amount of laws, gun bans, official meddling or other band-aids can substitute for righteous defenders’ ability to shoot the perpetrators dead or otherwise incapable of further violence. *As the Talmud teaches, “If someone comes to kill you, strike him down first.”*

These truths have been known since the Bible was written and remain true to this day. Gran’pa Jack and his friends share them with his grandchildren in language even the president could understand if he listened. Reducing public access to the quality firearms and ammo our police and military prefer, as some misguided politicians are demanding, only makes matters worse, since we face the same adversaries—as the Orlando event showed. “The correct response to a mass murderer is not to restrict the public, but to empower the public and give us every advantage possible over potential criminals.” –JPFO Policy
