Demand Restoration of the Full Second Amendment:

There's no justification for how self-styled defenders of the Second Amendment defaulted facing abdication of the guarantee of the right to "a well regulated militia, being necessary to the security of a free State..."

A proper defense of the Second Amendment must defend it in full. Not by halves.

The first clause of the Second Amendment must be held as sacrosanct as, per the Heller case, the unfringeable personal right to keep and bear arms, lest the entire bundle of rights to arms be weakened. We must not let leftists pull the rug out from under us by blithely ignoring the Second Amendment's first clause, thereby setting an insidious precedent.

Joining or participating in a well-regulated militia, state-chartered or auxiliary to the National Guard, reporting to the elected state

governor, without age limitation or other arbitrary restrictions, confers honorable status. It will provide a way to issue taxpayer-funded weapons and ammunition to its members, provide training, drilling, discipline, and the legitimate exclusion of violent criminals and those dangerously unstable. As well it should. School systems themselves can and should provide at

least one of the vehicles for ensuring a populace well trained in the military arts and sciences a militia must know.

Restoring the right to a well-regulated militia protects the letter and spirit of the Second Amendment as a bulwark against tyranny. Doing so also will expose the hypocrisy of those who hypocritically claim they are not against gun ownership, merely against so-called "gun violence," a concocted term designed to belittle the honorable place firearms hold in American history.

Switzerland had universal Army service and a gun culture as great as America's. Having the equivalent of a well-regulated militia cut their crime rate by 90% compared to ours while it served in good order. The left's resistance to well-regulated militias would hoist it on its own petard, its hypocrisy—their purpose being not reducing criminal misuse of arms, but eviscerating a major provision of the Bill of Rights—clearly revealed!

We fully support the right of the law-abiding to keep and bear arms for self, family, and home defense. We fully support the right of the law-abiding to keep and bear arms to hunt. That said, *neither the ancillary purposes of personal defense nor hunting were why the Second Amendment was put into the U.S. Constitution.*

"Crime Bill" Really a Gun Ban Government keeps its guns, you don't

Ammunition Demand Will Not Subside Soon

Ammunition consumers indicate that demand will remain strong well into 2021. According to Southwick Associate’s ongoing shooting sports consumer market research, multiple reasons are driving the continued unparalleled demand.

In April 2021, Southwick Associates surveyed more than 1,800 ammunition consumers as part of its quarterly HunterSurvey/ShooterSurvey tracking study. In 2020, four out of five consumers encountered out of stock issues while trying to purchase ammunition, while three-quarters encountered out of stock situations so far in 2021. Of these respondents, 79% reported either fully or partially reducing their target shooting and hunting outings as a

result of depleted ammunition shelves.

Going forward, ammunition demand is expected to remain high. Nearly two-thirds of ammunition consumers report their current ammunition inventory was lower than they would prefer. When asked how much more ammunition they would like to have on hand, 43% reported “much more” while 38% reported “a little more.” Only 17% were satisfied with the amounts they currently had on hand.

When asked why they desire more ammunition, key reasons included:

- Uncertainty about future ammunition supplies (72%). This is especially true among consumers 45+ years of age.
 - Uncertainty about future restrictions on ammunition purchases (70%).
 - Uncertainty about future conditions (54%).
 - Increased shooting and hunting activity (26%).
- This was more common among the 25-34 year-old consumers.

“At some point, demand will certainly soften,” reports Rob Southwick, President of Southwick Associates. “However, frenzied purchasing and empty shelves often fuels further increases in demand. We do not see demand softening in the near future.”

Southwick Associates will release additional top-level insights regarding market and consumer trends in the hunting, recreational shooting, and home/away defense markets as they become available. Mass media somehow missed this story.

Gun Sanctuary States

JPFO supporter Sen. Warren Hamilton, Republican legislator in Oklahoma, saw his gun-sanctuary bill move and pass into law, with assistance from JPFO, joining other states that have taken action to curb federal infringement on the Second Amendment. It’s unclear how many states have so moved, or the strength of the individual laws but it’s at least a dozen, and many more localities within states. But the federal response has been clear—they do not like the challenge to their power. Federal authorities have no power to infringe on the right to keep and bear arms, at least no legitimate authority, and appeals to the Supremacy Clause in Article VI, are null and void if infringement is the bottom line.

Guns and Vote Fraud

Left and Right political factions charge each other with vote tampering of various forms (e.g. Russian collusion, ballot harvesting, etc.). Judicial Watch and the Institute for Justice have numerous examples of election fraud that are serious if not enough to change the result of the 2020 presidential election. State audits could clarify the matter, but the left and the so-called “news” media denies this and fights against it. Nothing is going to remove the current occupant of the White House—there is no mechanism for this—but it will impact the management and mechanisms for the next election in 2022. Since the right to arms is now hotly debated and directly related to who’s

The JPFO Confiscation Clock inched two minutes closer to midnight and paused perilously close to more motion, with Democrats' introduction of HR127.

This bill, described elsewhere in this issue, requires confiscation of many specified popular guns and ammunition owned by the public, in blatant infringement of the Second Amendment. It also outlaws any possession, transfer or sale of guns and ammo without federal permission, which government is not required to provide. Essentially it can be a total ban on all gun ownership—discretionary and arbitrary complete gun control—midnight by any measure. This is pure evil, and worse, government agents have exempted themselves from it all, they remain fully armed.

Several factors keep us from midnight. As of this writing, the introduced bill has not been enacted or even put up for a vote. If it passes both Houses and is signed by Mr. Biden, it will no doubt be immediately challenged in court, since it far exceeds any legitimate delegated authority Congress or a president has to enact law. If it makes it through the process, many scenarios are possible, and the JPFO Gun Confiscation Clock may well move past midnight, a disastrous place for America to find itself. Pray this does not happen. ☆

Real Anti-Semitism

JPFO has established that what people call *anti-Semitism* is really Jew hatred, but people are afraid to call a spade a spade. The Jew hatred we see today is pale to what history has shown us. Dov Marhoffer, a Holocaust survivor on JPFO's Board of Advisors, recalls the horrors of the past. A new video of Dov speaking at a JPFO political Salon event is posted at JPFO.org.

Anti-Semitism is on the rise. With your background from WWII, what advice would you give Jews today?

It was 85 years ago now, Jews experienced intense anti-Semitism in Europe when Adolf Hitler's National Socialists came to power in Germany. Most of them deluded themselves that this was a temporary fad, or that Hitler did not really mean what he said, and that everything would soon return to normal. After all, Europe needed its Jews. We were a very important component of Europe's society and economy, its leading scientists, academics, businessmen, and artists. They thought they were tax-paying citizens and that the state and city governments of Europe would protect them. Only a relatively small minority of European Jews were alarmed enough to escape Europe to America and to then-Palestine while the borders were still open.

The Jews of today delude themselves exactly the same way. Jew hatred in America is only a temporary fad, they think, or that the anti-Semites of today do not really mean what they say, and that everything would soon return to normal. Jews in America believe that America needs its Jews and that they are an important component of its society and economy, its leading scientists, academics, businessmen, and artists, and many of us are.

History is unfortunately repeating itself in my own lifetime. Every society and every age needs its Jewish scapegoats to blame and to pogrom when society and the economy crumble. Jews in America have not learned the lessons of 2,000 years of Jewish history in the diaspora.

Jews need to strongly oppose the wave of anti-Semitism *now* while they still can and the wave is still manageable and not procrastinate until it is too late. They need to rely on themselves and not on anyone else.


Some Jews say our guns can't help. How do you respond to that?

Guns *always* help. Especially now in the earlier stages of the wave of anti-Semitism, when the haters are individuals and small groups that can be opposed and deterred. If American Jews sit on their hands and do nothing now when the hatred is manageable, it will grow and become unmanageable later. I remember in 1990 when there were riots in Los Angeles after the Rodney King beating. The Korean store owners protected their stores with guns and their stores were not looted and burned. If Jews had guns—and the willingness to use them—back in the 1930s, maybe Kristallnacht in Germany could have been handled early on.

Even poorly armed Jews during World War II could have caused tens and hundreds of Warsaw Ghetto uprisings. Those could have diverted the Nazis' attention and military resources that were needed to fight the Allies. It could have shortened the war and saved other Jews from the concentration camps.

Jews need to depend on themselves and remember what is says in the Torah:

"Whoever comes to murder you, kill him first."



Without any firearms, the chances of Jewish survival are minimal. An old adage is poignant here—if the Arabs would lay down their arms we would have peace in the Middle East. If the Jews lay down their arms, there would be no more Israel.

What would you tell school teachers who don't want their children to know about marksmanship, firearms use and safety?

The teachers who refuse to let children know about firearms, safety, marksmanship and how to defend themselves are raising a generation of victims who will go like sheep to the slaughterhouse. Teachers who refuse to learn from history are not really teachers. They should be replaced with teachers who have an appreciation of history and common sense. Censoring knowledge of firearms is wrong.

Some people say modern Jews have their heads in the sand. Is that true?

To a great extent, this is sadly true. Jews who do not own guns, who do not know how to use them, and who are not prepared mentally, emotionally, and physically to defend themselves, their families, and the Jewish community are going to be victims.

Why do so many people hate the Jewish people?

Christians in the Middle Ages hated Jews for not converting to Christianity. Muslims today hate Jews because in the Koran they read and know that Mohamed hated the Jews who would not convert to Islam. In the days of Mohamed in the 8th century, Saudi Arabia used to have Jews, but they were all exterminated or converted to Islam. The other big reason for the world hating Jews is that Jews have been economically successful wherever they settled and there is tremendous jealousy. Instead of following the example of the Jews, investing in their children's education, and making a better life for themselves, many people would rather turn on the Jews.

Are Arabs in the Middle East the new Nazis?

No, Arabs in the Middle East were this way as far back as the 8th century, 1,200 years before Adolf

Hitler and the National Socialists. They wiped out all the Jews in Saudi Arabia in Mohamed's lifetime. You might say the Arabs were the inspiration for the Nazis.

They pioneered ordering Jews to wear distinctive clothing, they set aside specific neighborhoods where Jews were forced to live, they destroyed synagogues, and they regularly massacred Jews. In 1929, before the Nazis came to power in Germany, the Arabs massacred 70 Jews in Hebron. This was before there was a State of Israel and everything was under the British Mandate of Palestine. The person who instigated them was the Arab leader Haj Amin Al Hussein, the Grand Mufti of Jerusalem. He later met with Adolf Hitler in 1941 to discuss their common "Jewish problem" and how to exterminate us like termites. *How can you understand that people think that way and not want to own guns?* By the way, Haj Amin Al Hussein was also the uncle of Yasser Arafat, the terrorist leader of the Palestine Liberation Organization.

Tell us a little about what it was like after the war.

I was a child when the Russians liberated us from the concentration camp. There were many terrible things in that place. Please let me make one point here. *No one was killed in the Holocaust. They were murdered.*

My mother and I went back to our hometown and found that our house and land were seized by the Russians. We traveled slowly for two years from Eastern Europe to Western Europe to board a ship to British Mandate Palestine. Our story was very similar to the one in the book and 1960 movie "Exodus" by Leon Uris. Many Jewish refugees were huddled in our rickety ship. A voyage that should have taken less than a week lasted more than three weeks. Our ship was captured by the British Navy near the port city of Haifa and was towed to the Island of Cypress. We lived in a camp surrounded by barbed wire for more than a year until May of 1948 when Israel declared its independence and we were allowed to go there.

If you could do one thing what would it be?

I already do this, but I do public speaking about my experiences in the Holocaust to students in elementary schools, high schools, and universities. People need to learn about history so they avoid the mistakes of the past. It shocks me that so many students know so little about it, or even refuse to believe it happened. *The school system is not educating our children.* That must change.

If you could do one thing to help the Jews in America, what would it be?

As I stated above, I do public speaking about the Holocaust. I would ask your readers to invite me in to speak to their schools and groups. I would en-

courage every American Jew to: 1) learn how to safely use a firearm; 2) own a firearm; 3) practice regularly; and 4) connect with other Jews through organizations like JPFO. All Americans should know firearms.

What do you say to Democrats introducing bills to take guns away from the public?

I am a registered Democrat, but the politicians of my party are making an enormous mistake. Every dictatorship in the 20th century that massacred its own people started by disarming them, to force them into obeying new totalitarian laws and make them easy victims. This was the story with Nazi Germany under Hitler but also the U.S.S.R. under Josef Stalin, China under Mao Tse-Tung, and Cambodia under Pol Pot, and in Latin America and in Africa. [Editor's note: JPFO has documented these facts on its website, JPFO.org.] The genocides that happened in other countries can also happen in America because human nature is the same everywhere. If the Democrats succeed in disarming the American public, they, their children or their grandchildren will eventually be in concentration camps just as I was because people who forget history end up making the same deadly mistakes again and again.

If you could write and pass one new gun law, what would it be?

The new gun law I would propose would require every high school student to learn in school how to use firearms safely to defend themselves. Learning how to use firearms is important to teach safety, but is also important to de-mystify guns. Many people are scared of guns because they are unfamiliar with them and have never seen them outside of television and movies. Also, learning about guns helps overcome a victim mentality. I would be in favor of another law that all law-abiding adult citizens, who learned how to safely use a gun in high school, should own a gun for their own protection and that of their family.

You know your son is a really good shot. What do you think about that?

I am happy that he is able to defend himself and others, but every shooter can stand improvement. Marksmanship is a lot of hand-eye coordination and is a perishable skill. Being a competent gun owner and user requires regular, weekly practice just like professional sports or the skills quickly deteriorate. ☆

The purpose of the Second Amendment was to create a balance of power—a bulwark against a tyrannical federal government. Even the denialist *Washington Post*, publishing historian Noah Shusterman, is forced to admit that:

Alexander Hamilton, writing in the *Federalist Papers*, called a well-regulated militia 'the most natural defense of a free country.' His anti-Federalist critics agreed with the need for a citizens' militia, writing that 'a well regulated militia, composed of the Yeomanry of the country, have ever been considered as the bulwark of a free people.'

Conservatives and originalists like us don't air-brush words out of the Constitution. Ignoring plain

constitutional language is a reprehensible but familiar left-wing tactic. The Second Amendment, in its fullness, recognizes that a well-regulated Militia is indeed necessary to the security of a free State. We have lost sight of this at our grave peril.

The very dangers that now assault us are all the proof one needs to see that, without countervailing force at the state level, federals have retracted our rights to assemble, worship, speak freely, travel and act as we would as free citizens. It is time for that to end, and well-regulated state-based Militias, as contemplated by the Founding Fathers in the critical first half of the Second Amendment, are the obvious solution.

A proper defense of the Second Amendment must defend it in full. Not by halves.

Demand and assemble the constitutional right to a well-regulated militia! ☆

The Idea That Kills

The book I wrote with attorney Richard Stevens, *Death by Gun Control*, is not just about “gun control” laws. The book is about “gun control” as an idea. The “gun control” idea outcrops in many forms, but it boils down to these two fundamental beliefs:

- (1) Only a government has any *right* to have an use firearms.
- (2) Citizens have no *right* to use armed force for defense against aggression (i.e. crime, invasion, repression, violence, etc.)*

The “gun control” idea, as explained in this book, means training decent non-violent citizens to:

- Hate, fear and avoid guns as objects
- Shun and ostracize civilian gun owners
- Favor laws that restrict or prohibit firearms possession and use
- Accept as normal that citizens should be powerless to overthrow an oppressive government
- Applaud government's using armed force to achieve foreign and domestic policy goals
- Depend on government agencies to protect individuals from aggression and crime**

The “gun control” idea implants hatred and fear into the hearts and minds of people. The “gun control” idea breeds attitudes, slogans, policies and laws that kill.

Death by Gun Control shows exactly how “gun control” means victim disarmament—and how victim disarmament leaves millions of innocent people vulnerable to aggression: abuse, rape, robbery, murder, and government-made genocide.

To save millions of innocent lives, we must not merely modify or repeal certain “gun control” laws. Our book shows why there can be

no compromise. We must destroy the very idea of “gun control.” ☆

**Editor's Note:* It's important to keep the ideas of *rights* and *powers* distinct, which government and writers frequently confuse, often deliberately. People (and in limited cases states, versus the federal government) have rights. Governments have powers only, and only as legitimately delegated to them by the people. Powers exercised without delegated authority is *usurpation*, or tyranny. America suffers under a lot of this lately, but: “all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed,” as the Declaration of Independence wisely points out, so here we are.

People have every right to use force against crime, invasion, repression, violence, for the preservation of innocent life and against unjust threats to property. Government can only act in such a manner when it has been given such power by the people—the familiar phrase, “by consent of the governed.”

** This widely promoted myth is dangerous and must be exposed. In another JPFO book, written at Aaron's request by Richard Stevens, *Dial 911 and Die*, this lie is torn to shreds. By common law, common sense, and statute in all 50 states, police are under no obligation to protect any individual. You are on your own. Police have a duty to the public at large, to community safety. Often enough they do not live up to that, as we have all witnessed recently, with zero repercussions for massive failures in that regard. “To Protect and Serve,” is an advertising slogan, not a policy.

It must be this way, when you examine it. If police had any duty to protect every individual, they would be instantly sued out of existence, because it is an impossible task. They cannot be everywhere

at once, even if they were infinitely staffed and funded, which they are not. There must be fewer police than populace, compounding the task. Bottom line, you are responsible for you. You are the first responder.

Even in the most egregious cases, where police got repeated calls for help, from people with orders of protection against known violent repeat offenders at the door, and then went to lunch resulting in death of the victim, no guilt was found. Police have no duty to protect you, it is settled law, Supreme Court affirmed. What does JPFO say about that? Get a gun and learn how to use it. Harden your home. Study tactics and strategy, especially less-than-lethal options. The gun is the last resort. “The best gunfight is the one you avoid.” Life is precious—you're expected to protect it.
