### All or Nothing vs. Incrementalism

This correspondent has been involved in the struggle to restore Second Amendment rights for more than 50 years. In the 1980s, a major question was: Must we restore Second Amendment rights all at once, sweeping aside all infringements of The Right to Keep and Bear Arms at one blow? Or should we chip away at infringements bit by bit, winning a legislative battle here, building on it next session, educating legislators, building networks and legislative expertise, restoring our rights, incrementally —as they had been taken away?

Call the two schools of thought the "All or Nothing" group vs. "Incrementalists." The All or Nothing group argued an incremental approach would validate infringements. The Incrementalists argued the way to eat an elephant is one bite at a time.

Time has shown the answer. Incrementalism has been spectacularly successful. In 1986, only one state, Vermont, had Constitutional Carry. It was truly constitutional—they had never enacted any infringements on the Second Amendment.

Do you remember the slogan during the struggle to restore our right to carry, "I want Vermont?" The term Constitutional Carry was created during Arizona's effort to bypass the need for permission-slip permits. They couldn't very well say they wanted Vermont.

America had eight shall-issue states. The Supreme Court refused to consider Second Amendment cases. In 2023, there were 26 Constitutional Carry states and a permitless carry state, Florida. Louisiana and South Carollina are expected to join the Constitutional Carry club this year. Fifteen states are Shall Issue. Eight states are May Issue. The Supreme Court has ruled the May Issue states must become Shall Issue.

All the additional Constitutional Carry states were first Shall Issue states. They became Constitutional Carry states with incremental steps. Alaska was the first state to restore Constitutional Carry. It did so because those opposed to Constitutional Carry were worn down and gave in. A Democratic legislature said it was tired of the fight, it wasn't worth it. *Continued on Page 2*

#### Rabbi Pesach Wolicki, Exec. Dir., Israel 365 Action

AK: Rabbi please tell me, how easy or hard is it to get a gun in Israel? PW: I've lived in Israel for over 30

years. Especially over the last few years, the government has been promoting gun ownership by citizens because *our government recognizes that everyone is safer when more citizens own guns*. They've made it easier. It used to be that your job had to be of a certain type, or work somewhere where it was more dangerous, but that's no longer the case. All you have to do is apply for a permit. You have to take a course, they want to make sure people know how to handle a gun, but most Israelis do, because we all serve in the Army. It's very easy now. The whole process is expedited.

AK: We've heard the opposite here, that guns were very hard to get. When you got out of the IDF (Israeli Defense Force) you couldn't *Cantinued on Page 3* 

### **Ancillaries to Liberty**

Deception has taken on a new legal cloak in the form of an argument which states that ammunition and magazines are not protected under the Second Amendment. This argument has been used in many court cases with varying degrees of success. Some activist judges (a.k.a. oath breakers) have agreed with this anti-historical, fallacious position and wrongly ruled that the Second Amendment does not protect your right to magazines and ammo.

This falsehood has found favor with the gun prohibition lobby which peddles it along with their menagerie of other calumny against the Second

Amendment. Splintering out naturally from this putrid lie is the idea that the right to life does not include access to air. It's possible that some may take such a statement as mere hyperbole, but is it? The ones who strive unendingly to disarm you have, at best, a callous disinterest in your necessary ability to survive and, at worst, a malevolent animosity toward it. It's not difficult to imagine their future arguments being indistinguishable from that, extending effortlessly from their baleful ideology.

However, the question remains, is it correct? Is the Second Amendment silent on the matter *Continued on Page 3*

### Everytown for Gun *Safety* Suicide?

Everytown continues to relentlessly push its evil, anti-liberty campaigns across the nation in an effort to disarm the America people. To that end, they strongly support Extreme Risk Protection Order (ERPO) laws, especially those which grossly violate due process. At the same time—having finally admitted the fact that the vast majority of deaths involving firearms are suicides—they're, at last, promoting suicide prevention by publicly disseminating suicide prevention hotline phone numbers and other resources. While we at JPFO certainly encourage that effort in general, we have to wonder if they are actually stigmatizing the use of those resources in the process.

As they continue to push ERPO laws all over the country, they are helping to create an environment where those who find themselves in a mental health crisis are put in an even more precarious position than the one which created the crisis in the first place. Since many ERPO laws allow police to (often summarily) disarm people who are "a danger to themselves," some people may come to think that anyone who calls an Everytown-promoted suicide hotline may be putting themselves at risk of being compulsorily disarmed by the police. For many people, this threat could be the very deterrent that would prevent them from seeking help when they need it most.

A study by RAND [Effects of Extreme Risk Protection Orders on Suicide. (n.d.). RAND. https://www. rand.org/research/gun-policy/analysis/ extreme-risk-protection-orders/suicide. html], updated in January of 2023, found that the effects of ERPOs on suicide rates are uncertain and therefore, the evidence, inconclusive. Despite this, Everytown's due process violation laws would force a person in mental crisis who is seeking help, to be faced with the added possibility of being disarmed against their will. For many people who value the ability to have a gun for self-defense, this would be the factor that would discourage them from seeking the help they so desperately require.

Everytown, being woefully out of touch with gun owners, lacking even a basic understanding of the Second Amendment and possessing a conspicuous enmity with liberty—namely the right to keep and bear arms—seems to be fostering an environment of hostility. And this animosity is specifically targeted at gun owners in crisis who need mental health services. Whatever their intentions in this matter, their attacks on freedom are causing those in need to be put at unnecessary risk.

While Everytown and their ilk are undermining mental health care through their constant, concerted attacks on the Second Amendment, organizations like Hold My Guns (holdmyguns.org) are helping to promote mental well-being though partnerships with FFLs across the country. People in crisis who can't ask family and friends to keep their guns, can take their guns to an FFL who partners with Hold My Guns and have them securely store their firearms until they feel ready to come back and pick them up. Groups like Hold My Guns are addressing the problem of mental health head-on, helping firearm owners without stigmatizing and punishing them.

Everytown's mission of disarmament and establishing "red flag" laws are simply incompatible with promotion of mental health support by crisis hotlines. In many ways, their actions resemble the ATF's luring invitation for gun owners with legal questions to contact them. Under no circumstances would any sane, rational, informed person willingly contact the ATF with legal questions and put themselves in harm's way while merely trying to comply with the law. In that light, many gun owners feel that to reach out to a mental health crisis support group promoted by Everytown et al. could put them in jeopardy of having their rights stripped from them.

JPFO encourages gun safety and promotes mental health and spiritual wellbeing. In the event you or someone you know is in the midst of a mental struggle, please seek help from a group which will respectfully and genuinely assist in time of need. JPFO supports such groups that provide help without condemning or threatening the person in need. To that end, a lifeline is provided below. \$\phi\$

The same happened over and over again. The Supreme Court followed the trend and recognized the Second Amendment in the 2008 *Heller* decision, after ignoring it for 74 years. That was followed with the *McDonald* decision, applying 2A to all states.

We have restored much, using incrementalism. We have much more to do. The battle is in the courts. Perhaps we have arrived at a time for All or Nothing, at least on parts of it. Which is incrementalism again. ❖

AK: Then how did the kibbutzim get caught so flat footed when Hamas committed its attack?

PW: That's part of the problem. The shrinking left wing in Israel, which, if you follow Israeli politics, has been shrinking over the last few decades, Israel has become increasingly right wing and nationalist. That's part of the political turmoil lately. But the

left wing is more anti-gun, but they're shrinking. Those kibbutzim (the ones on the Hamas dividing line) were mostly left wing, not a lot of guns.

AK: Rabbi, how well armed are Israelis now?

EM: The way it is now, you can't live without guns.

AK: So we hear that there isn't easy access to guns and the government has disarmed the people.

EM: Absolutely not. Check with Itamar Ben-Gvir, he's one of the ministers of the government now, he's a religious Zionist Jew, and he's made it his priority to relax gun laws now in Israel since Oct. 7th. They have a record number of applications for guns right now. Hundreds of thousands of people are applying for guns right now in Israel, and they have overwhelmed the office. They

of magazines and ammunition? The very simple, obvious answer is that it's silent in the exact same way the First Amendment is silent on words, paper, quills, and ink. The Supreme Court has already correctly found that certain rights invariably contain within them ancillary rights necessary to the function of the primary right. One cannot truly exercise his freedom of speech without the tools required in the normal operation of that right. The Second Amendment says nothing about bullets, patches, powder, triggers, magazines, cartridges, scabbards, belts, etc. But these things are required operational components (as air is for living) and are therefore presumptively protected from government infringement under the Second Amendment. Only the wildly ignorant or particularly evil person could make an argument to the contrary.

Another similar position is that certain and specific guns, ammunition types and magazines (such as magazines that hold more than ten rounds) February 2024

are not protected under the Second Amendment. This argument closely resembles the previous argument in both form and absurdity. As modern forms of communication and media such as TV, radio, telephone, and computer are presumptively protected under the First Amendment from government infringement, so too are modern iterations of firearms and their components.

The obvious nature of the counterpoints to these anti-liberty arguments implies that the people pushing them are very likely doing it knowingly and intentionally with the dark purpose of making us all helpless, subservient chattel. They are the villainous, oppressive tyrants about whom the framers warned us so emphatically and so often. And the nihilistic, sociopathic enemy who would unjustly take your firearms, would gleefully take your life and the lives of those you love. \$\Phi\$

actually changed the law. It used to be—I only moved to Israel in 2021—it used to be you had to wait three years or five years depending on where you lived. That rule went out the window after Oct. 7 and we're all applying for guns now.

AK: You mentioned that in the South, where the Hamas assault happened, they're liberal?

EM: Most of the communities that were slaughtered by Hamas terrorists on Oct. 7, most of them were very liberal left-wing secular communities, like the peacenik communities. Before Oct. 7, they would take people from Gaza and drive them to hospitals in Israel, they were all in on peace no matter what. Obviously, they've changed their tune now that they've lost so many of their loved ones in this terrible tragedy. In general they had very, very few guns. I went down there a few weeks ago, to a border community, called Aina Besuer, they had four guns in the entire community. On the other hand, there were the very religious communities down there where everybody had guns. And so they fared a lot better on Oct. 7.

AK: It's similar here. The Chabads (orthodox institutions) understand it, the congregants have guns, Rabbis know who's armed, they welcome it. The conservative, and the reformed shuls, they've become secular left wing and virtually Marxists. They hate guns, don't want them.

EM: Jews all over America now, I mean, I know several, are applying for guns, they're doing the best we can, because we know we have to defend ourselves. \$\pm\$

A closing thought: The Hamas attack surprisingly murdered so many of the people who supported them, living on the border blissfully daydreaming of peace, oblivious to the danger these terrorists represent. They paid a tragic price for that willful ignorance.

SAF has filed more than 250 lawsuits and has removed more than 600 local anti-gun-rights laws from the books simply by threatening to go to court. SAF's new Executive Director, Adam Kraut, a practicing civil-rights attorney based in the Philadelphia area, said, "We're just getting started."

### Dems Still Seek to Ban Working Guns

HR 660 by a Connecticut legislator would make it a crime to have a firearm that is not locked away if a child could get it (mandatory home storage, HR660). How agents would determine this is unclear. The proposal violates the *Heller* decision banning such bans, and the 4th Amendment against unwarranted search and seizure, unless Dems have some magical way to assess the status of all your guns.

#### **Teach Children About Guns**

Many American Jews hail from Poland, who came over during the immigration swell in the early 20th Century. That source of the diaspora is now learning a lesson: "History is not over," said Polish Education Minister Czarnek, "it repeats itself and you have to fight back." He got a law enacted to restart military training in schools, which stopped in 2012.

Eighth and ninth graders Poland-wide are getting "lessons in rifle safety and basic defense training," including live fire at a range. This, "met with predictable pushback from teachers," according to The Week, a sentiment parents didn't seem to support. One girl's mother said gun training should be more frequent, "so the children can really master it." JPFO typically avoids international issues, but there are lessons for

us domestically, before we're invaded and it becomes impossible.

#### **The Political Divide**

The gun debate basically divides into two camps—the gun-owning "Just leave us alone" camp, and the gun hating, "We want to control you" camp. I see these fundamental human and political characteristics play out everywhere, a great reason to be armed.

## Extreme Risk Protection Orders (ERPOs)

Oregon Audits Division said (admitted?) their so-called "red flag" law's primary purpose is stopping firearm-related suicide. Anti-gun-rights activists have insisted it's to disarm armed criminals (though that obviously isn't working). The Audits Division also brilliantly noted that suicide-by-firearm-attempts cause more deaths than other methods, and most people only attempt suicide once. "Auditors looked at ERPO (red flag) laws in 21 other states and the District of Columbia and found Oregon's to be generally in line with best practices and model legislation," their news release said. However, the auditors say ERPOs are not being used as much as in other states; they comprise fewer than 1% of all their protective orders.

#### **Gun Sales With No Checks**

National checks only started with Brady in 1994. Once gun-rights advocates saw checks were a *fait acomplis* with the biased media campaigning for them so hard, they wisely insisted, as a fall-back position, *sales have to be completed without the checks*, if government fails to do them. As originally drafted, officials could simply closedown gun sales totally nationally by never doing checks. "Trust us," was the attitude.

Now we learn, the FBI and BAT-FE, in 2020 and 2021 failed to get 1,000,000 "instant" checks done in the allotted three days. This allowed sellers to complete sales without checks, preserving rights for those delayed. The "overwhelmed" FBI never got 734,000 of the checks done, and of the finished ones, 11,564 ended in denial, though no court conviction or independent review is part of that process ("pre-

sumption of guilt" and rights denial, with complex appeals). Our legislators included a tremendously needed three-day safety valve.

#### **Make New Crimes?**

# **Rights Insurance**

Insurance is a good thing to have when you need it. In fact, it can be a lifesaver in many situations. Most of us hold some form of insurance whether it be for home, auto, life, medical, etc. But what about self-defense insurance? There's no doubt that it would be good to have a lawyer on retainer if such an unfortunate incident befell a person. But, while it may be good to have, should you be required to possess it?

Some politicians say, yes, you should have to be covered by liability insurance before you are able to carry a firearm. After all, some states require you to have car insurance to drive on public roads, so why shouldn't they be able to mandate you to have coverage for carrying a firearm in public places?

To clearly see the preposterous nature of this outrageous claim, we need only look to other natural rights protected under the Constitution. There seems to be no politician making a serious claim that there

should be a law which requires a person to have insurance before they can practice their religion, speak freely, be free from unlawful searches and seizures, or be free from torture and slavery

The lack of mandatory insurance legislation on these rights implies why such politicians may think hiding the right to keep and bear arms behind an insurance paywall is justifiable; simply put, they view our natural right to keep and bear arms as a second-class right, outdated and inferior to other rights, undeserving

of their oath of office.
