

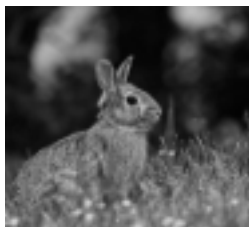

## Rabbits and Weasels

Most gun owners have had to bear listening to cringe-worthy statements like, “No one is coming for your guns,” “No one wants to ban guns,” “We just want common sense gun laws,” etc. These, and other putrid lies like them, have been spoken over and over again for years now by nefarious politicians, anti-liberty advocates and other haters of freedom.

On June 26, 1934, oathbreakers and cowards in Congress passed the National Firearms Act (NFA), sold to the public as a means to keep them safe from criminal violence. Its function was to

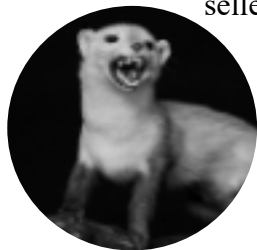


create a burdensome tax on citizens who purchased certain weapons such as automatics. Its true, ghastly purpose was to make the purchase of items listed in the NFA cost-prohibitive and to allow the government to create a de facto registry for tracking registered items and their owners (those fortunate

enough to be able to afford the exorbitant cost of the “tax stamp”).

Then, in 1968, spineless members of Congress, having no loyalty to their oath, office, country or constituents, voted in favor of the Gun Control Act (GCA). It was signed into law on October 22, 1968. Prompted by the assassination of president John F. Kennedy in 1963, and applauded by Vice-President Franklin Orth of the National Rifle Association, its primary purpose was to prevent mail-order purchases of certain firearms.

In 1993, the Brady Handgun Violence Prevention Act amended the GCA to require background checks for people buying from licensed dealers (FFLs). As of this writing, the Fifth Column’s star, anti-liberty agency—the ATF—is again trying desperately to end around congress to make this apply to sales from even private sellers.



They banned or restricted various weapons in the NFA in 1934, added to its infringements in 1968 with the GCA which was amended

## Road to Colorado

Colorado, a state once admired for its rugged independence and breathtaking landscapes, now finds itself entangled in a web of bureaucratic mismanagement and misplaced priorities. While its roads crumble and its infrastructure strains under neglect, Colorado's government paradoxically sets its sights on tightening the reins of 2A liberty—a fundamental right that must be sacrosanct in any free society.

As potholes and cracks multiply, lawmakers in Denver believe they are fit to dictate the extent of citizens' rights to keep and bear arms. Colorado's ongoing legislative maneuvers reflect a disturbing trend of overreach—now, sadly typical of the state—that threatens to reduce 2A liberty to nothing more than a government regulated privilege and extend its writhing tendrils greedily out beyond freedom protected under the Second Amendment into others until nothing is left but a “mother may I” state. The state's leadership, emboldened by partisan agendas and pressure from anti-freedom lobbyists, has enacted laws that chip away at citizens' natural rights guaranteed by the Second Amendment. They justify their actions under the pretense of public safety, echoing tired, false slogans about

## Compassionate Tyranny

Wringing hands and clutching pearls, sadly, seems to be the bar by which the validity and constitutionality of anti-2A law is measured in many states. “Safe storage,” “red flag,” and “gun safety” laws (to name a few categories) are largely based on unfounded and untested assumptions by the most vocal and irrational anti-liberty NGO members and legislators. But whatever they lack in facts, critical thinking,

research, data, history and constitutionality, they implicitly claim to make up for in so-called “morality.” Or, as most sane, thinking people view it, the morally-abhorrent stance of self-defined and forcefully-imposed morality based purely on the bile of feelings, the “greater good,” and the depraved theory of moral relativism.

For the sake of argument, this writer (this time)

"common-sense gun laws" while doing little-to-nothing to address actual crime or punish criminals.

Even as Colorado's roads crumble due to neglect and budget mismanagement, so do its commitments to upholding constitutional freedoms. The National Firearms Act of 1934, the Gun Control Act of 1968, and subsequent legislative intrusions serve as bold historical markers of encroachment on 2A rights nationwide. Now, Colorado eagerly joins the ranks of states where government evil trumps individual sovereignty, where the allure of power and control eclipses the imperative of responsible governance.

In full light of its bureaucratic failures, Colorado's inept leadership continues to push for draconian measures, ignoring the lessons of history and their due allegiance to the


Constitution. The state's roads reflect the abject failure, dishonor, and lack of courage that pervade its legislative halls. Meanwhile, the assault on Second Amendment liberties persists, driven by an insatiable appetite for more power and an absolute disregard for the principles upon which this country was founded.

As Coloradans attempt to navigate crumbling infrastructure and impositions on freedom, the Colorado government continues to demonstrate a predictable hatred of liberty and of its citizens. The path forward for Colorado, and every other such state, lies not in further encroachments on liberty in the name of "public safety," but in a renewed and proper commitment to responsible governance and respect for the right to keep and bear arms protected under our Constitution.

Despite our 2A rights being under constant attack, the thought of dying in the name of liberty is somewhat contradictory from an individual perspective. A person's lack of life could potentially make their enjoyment of life, liberty and the pursuit of happiness a rather difficult prospect in the long term. again in 1993. They banned some semi-auto rifles in 1994 for 20 years, followed by a resurrected attempt to ban them in the following years. Next, they went after magazine capacity, semi-auto shotguns, pistols and many, many other things. They soullessly continue to inflict damage to the liberty of citizens, all the while gaslighting us saying, “No one wants to take your guns.” As they seek to abolish due process through “red flag laws,” they say, “we just want reasonable gun safety laws.” As they try to ban nearly every semi-auto rifle in existence they say, “No one wants to ban firearms.”

A rabbit sits very still, watching the weasel circle. The weasel, playing its seemingly innocent games, circles over and over, slowly and imperceptibly closing the gap between itself and the rabbit. The rabbit, unaware of the danger as the distance closes, watches the weasel for a sign of aggression, oblivious to the ongoing and subtle maneuvering by the predator. gives these morally bankrupt individuals the benefit of the doubt and assumes good intent on their part (though that is certainly not always the case in reality). As the old adage goes, "The road to hell is paved with good intentions." So, too, is the road to civilian disarmament which seamlessly joins the former road in short order. Guided by unregulated feelings and condescending, sanctimonious compassion, "goodwill" tyrants strike without doubt or hesitation against those liberties they deem too dangerous for us, lowly, ordinary people to wield. Unencumbered by sincere introspection, they shackle us, presumably, for our own good, leaving no room for challenge or dispute.

Devoid of any relevant research or even basic knowledge on guns and self-defense, they push for "safe storage" laws which, in nearly all cases, render a citizen's gun inoperable and inaccessible in time of need. Not only do they ignore the indisputable, elementary fact that enforcement of such laws would require violation of citizens' rights protected under the Fourth Amendment, but they also advocate for the safety of home intruders, unjustly laying compassion for criminals upon the corpse of compassion for their would-be victims. In good faith, we may look upon these errors as purely unintentional but what then can be said for the reasoning capacity of the person promoting such an atrocity? Or, perhaps, through some insipid mode of analysis, they have justified the sacrifice of our liberty for our safety. Arriving at such a conclusion could result only from one believing themselves masters to those they presume to make subjects, deeming them unworthy of liberty or incapable of exercising it "properly."

Relegating due process to a mere footnote in their analects of malevolent dictates, these tyrants

chisel away at it, subvert it, and reorder its importance in the lives of citizens. In stark contrast to Blackstone's Ratio, they blindly build upon the unstable presumption that it's preferable for ten innocent people to suffer than for one guilty person to escape justice. "Red flag" laws, in nearly all cases, void due process for the "greater good" and "safety of the community." Those who wantonly promote and support such usurpations of liberty hold a perverted view of justice, the U.S. Constitution, and, more significantly, the principles upon which it was founded.

The term, "gun safety," referring to a strict algorithm for proper firearm handling, storage, and use has been commandeered to mean "gun bans" by those who mishandle and attack our liberty in the name of "public safety." Unaware of the implicit lie spoken when misrepresenting the term, tyrants seek to replace actual gun safety with gun bans, believing, or at least selling,

them as one in the same. Despite the presumption that such bans are designed to "keep people safe," they retain their state-owned guns and seek a monopoly on violence, purportedly for "our own good."

concepts, ones which we can explore. For example, in mathematics, It can be problematic to define an odd integer. So, we use even integers to do it. Since we know all whole numbers multiplied times two, are even, we can prove the odd integer by saying any integer k times 2 is even and therefore 2k - 1 is odd. Such protracted peripheral examinations are very useful, especially when the heart of the matter is not so easily approached.

Even now, we suffer infringements that our Founders would never have accepted. They went to war, to revolution, for some much more tolerable violations than what we currently endure. But watering the tree of liberty is not a matter one takes lightly or speaks about in soft tones at the dinner table as it necessarily involves death and destruction even to the point your fine china may become damaged; a demoralizing consideration to say the least. In any case, the likelihood of your favorite movie theatre or restaurant pricing remaining the same is low at best. And, as death and inconvenience do offer a mild deterrent from us acting on our wish to be free, we often hesitate toward conflict.

As infringements mount, pro-liberty groups labor tirelessly against anti-liberty groups and bad government actors to maintain and restore our right to keep and bears arms. Under taxation—a practice literally synonymous with ancient methods of slavery—we toil, on pain of imprisonment and death, for a small group of ruling “elites” who dictate inflation (a tax on every dollar you have and everything you own), set rules for how money may be handled and, like any good dictator, how much of yours you must give to them so they don’t jail or kill you. They spend it on whatever they please, offering only a half-hearted pretense of caring what you think about their use of your labor dividends that they take by force.

As we cling to the small semblance of freedom remaining to us, they chisel and chew their way into our 2A rights, hoping to, through generational warfare, deplete both our will and supply. They stockpile and make laws on how many rounds we may have. They wield tanks, planes, bombs, rockets, grenades, and small arms beyond what any citizen is permitted to own while they whine and wince at our meager supply of lesser arms, greedily reaching out their hands to take what little we have left. Filing away the edges of liberty, they

leave us a husk of what we once had, screaming and pontificating about how it’s still too much. Still too dangerous.

Wherein do we resist beyond words when words do nothing? Your home is your castle. If they breach that, all is lost. When they seek to freely come into our homes to demand what they will of us, the dying hill is found. Under no circumstances can we relinquish our castles. 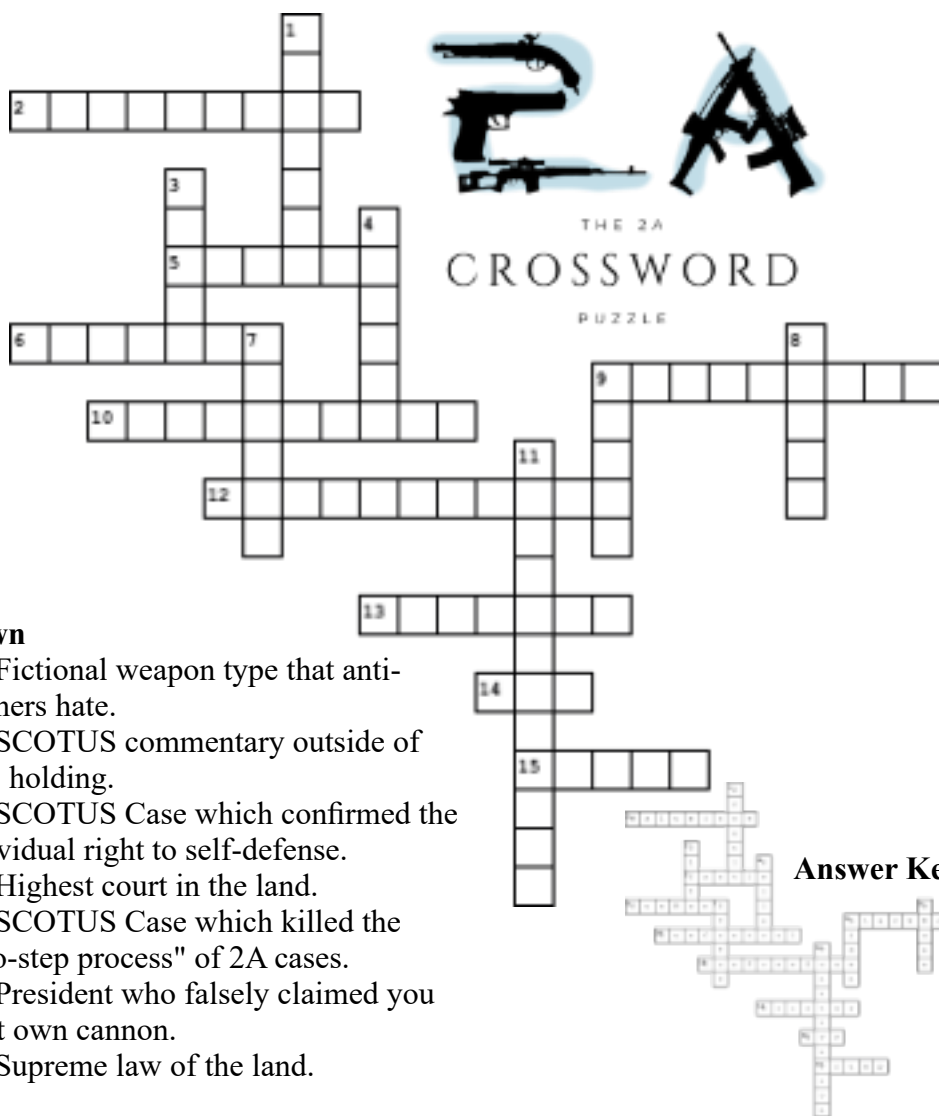

## Bia Lan...Let it Rot

Despite China's dictatorship being a model for up-and-coming tyrants like Justin Trudeau and the People's Republic of California's own Gavin Newsom, the system is epically failing. Their ideological possession is hidden only from those also possessed or willing to become so by their apathy, fear, or misplaced trust in government. In the moral wasteland, where those who have sold themselves for promises of power struggle against each other for

another’s share of the prize, there is nothing but contempt and disgust for anyone who chooses liberty, who protects and exercises their right to keep and bear arms, for doubt cannot grow in the light of certainty. With the clarity of responsibility for the defense of one’s own life, their rancid offers of safety have no appeal. Nevertheless, the contagion spreads, fear, and safety its power, legacy media and government mouthpieces its effective vehicles. Obscuring its true intent, it distracts the unwary as it quietly enters, planting doubt, then fear and watering them with narratives of necessity and urgency until those caught in its grasp succumb to its fetid will, bowing, relinquishing their right and responsibility of self-defense to the very entity that seeks their compliance, enslavement and, eventual destruction.
